- Click on "I am a student or parent borrower"
- Select "Arkansas"
- Select "NorthWest Arkansas Community College"
- If you have not previously accessed the OpenNet website, click "Register" in the third column under "First time user?" to create an online account
- Complete the requested information and click "Next"
- Log in with newly created User ID and Password
- Click on the box which says "Your Action is Required" - *Do not proceed if this box is not available.*
- Follow the instructions to electronically sign your MPN
- **Only the borrower may sign the MPN**

Signing a Promissory Note

When you sign a Promissory Note, you're agreeing to repay the loan according to the terms of the note.

- The note states that, except in cases of loan discharge (cancellation), you must repay the loan, even if you don't complete your education.
- Also, you must repay your loan even if you can't get a job after you complete the program or you didn't like the education you received.

The U.S. Department of Education does not guarantee the quality of education you receive or that you will find a job in your field of study.

Notify your lender or loan servicing agency when you:

- Graduate
- Withdraw from school
- Drop below half-time status (6 credit hours)
- Change your name, address or other contact information
- Transfer to another school
