International Student Transcript Evaluations

All documents submitted to the International Programs Office must be translated into English. It is best practice to obtain all necessary documentation for acceptance at NWACC and request a translation from one of the supplied location to save money. Some courses may need course descriptions provided to the evaluating agency. The agency you select will notify if this is the case.

The following organizations will evaluate foreign transcripts for a price. It is the student’s responsibility to have transcripts, diplomas, financial statements, and/or dependent documents translated prior to submission. If you are transferring to another institution, please note that although NWACC accepts evaluations from these evaluators, it does not guarantee acceptance by another institution.
