- d. Evening Weekend Bike Repair 115 to receive P-4, custom painted graphic

Question 7:

The finish schedule also indicates rooms 117&118 to receive E-EXP P-5 under the ceiling tag but has a note out to the side that says "no scope of work," which one of these is correct?

'No Scope of Work' was removed from rooms 117 & 118 due to P-5 will be added at Ceiling due to dry fall application being provided.

Question 8:

The finish schedule shows "VWG" in some locations and "VWC" in others. There is no specification for "VWC," can we assume these are the same?

Correct, VWG and VWC are the same. See response to question 6 on location clarifications.

Question 9:

Needing more details on the "VWG" to indicate what color/pattern will be used as the price per sqft can fluctuate drastically.

VWG is custom design and digitally printed type 2 vinyl wall covering

Question 10: the Bid Solicitation Document states the Last Day for written questions is July 24, 2023. Under Section 1 - 1.11 Clarification of Bid Solicitation states the RFI deadline is August 3, 2023. Please clarify.
