Action Items

1. Student request to plant a tree on campus

- Description of project request
 - o In celebration of the new Associate of Fine Arts degree at NWACC, the Art Club at NWACC would like to plant a Weeping Cherry tree on the lawn in front of the Donald E. White Auditorium. In this location the tree can enjoy full sun and students can enjoy passing through its waterfall of flowers every spring.

3. D.P.S. Offices Moving Location

- Description of project request
 - The relocation of DPS main office from Burns Hall to CHP, while maintaining an officer presence in Burns Hall. This relocation will allow for a much needed expansion. Physical structural changes and technology needs have been discussed with all necessary offices, including Construction Services, Information Technology, and the Physical Plant.
 - Ethan Beckcom requested moving the location of the D.P.S. main offices and the department of Policy, Risk and Compliance to the Center for Health Professions building. This move would better centralize Public Safety as well as increasing square footage.

Jack Thompson moved to approve, Jim Lay, seconded, Ethan Beckcom abstained. Vote: approved unanimously.

4. Adult Education Class moving to CHP 3rd Floor

- Description of project request
 - A new faculty member requires an office and classroom. The division requests utilization of CHP 3037, 3038, and 3039.
 - Adult education needs more classroom space and two office spaces.

Jim Lay moved to approve, Ethan Beckcom, seconded Vote: approved unanimously.
