Informational Items

Building Status Updates

• Integrated Design Lab

Debi Buckley and Jim Lay provided the group with a brief update on the Integrated Design Lab:

- 100% of the construction documents are complete. The project is in the bidding phase of the project schedule. The next step is the construction period.
- Groundbreaking for the building was July 20, 2018.
- The project is on schedule. Jim Lay and Dena Stone will provide updates to Dr. Tompkins about classroom availability.
- The project features a modern look that complements current campus buildings.
- The building will feature display systems and shelving for student projects.

• Washington County Center

Debi Buckley, Jim Lay, and Annetta Tirey provided the group with an update about the Washington County Center.

- The capital campaign for the project has entered the public phase. One-third of the campaign goal has been achieved. Efforts are ramping up to achieve additional donations.
- The project is on-schedule and is in the bidding phase. The next step is the construction period. The project is on schedule. Jim Lay and Dena Stone will provide updates to Dr. Tompkins about classroom availability.
- The College is continuing partnership with the City of Springdale.

- Space for Student Services and the Information Commons has increased slightly due to repositioning of HVAC units.
- The budget is being met by economizing with some changes.
- Furniture and flooring options are being explored.
- Space is included for general education, early college experience classes, other health professions programs, and nursing track for forty students.

Discussions around relocation of Physical Plant

Dr. Evelyn Jorgenson and Debi Buckley provided the group with information about potentially relocating the Physical Plant.

- The proposed site for the building would be the northeast section of campus adjacent to Watertower Road.
- The current physical plant building would be remodeled and utilized for apprenticeship programs in close proximity to Shewmaker and the College's construction technology program.
- The College would coordinate relocation with nearby road construction projects.
