**Hybrid Application Information** 

The PTA application is available June 1– November 1. The following forms are part of the PTA Hybrid application process and must be completed and submitted online by the November 1st deadline as part of the eligibility requirements.

These are the approved documents for PTA Program admission and supersede all other documentation.

#### ALL DOCUMENTS DUE by November 1 for the hybrid program

Dear Applicant,

Thank you for applying to the Physical Therapist Assistant Hybrid Program. This program was designed for students who wish to seek a degree as a Physical Therapist Assistant but remain living, completing clinical internships, and practicing in the areas in which they currently reside. Point and selection preference will be given to students applying greater distances from the main campus location. It is our desire to have this program provide for those in underserved areas who need access to quality and timely education. Therefore, students in the hybrid program will be required to complete a majority, if not all, of their clinical internships outside of Northwest Arkansas at the student's expense. In addition, we would like the graduates of this program to remain in these areas to serve the patients who desperately need access to individuals with a high-quality education in physical therapy.

The PTA Program application must be completed to be considered for acceptance into the professional phase of the PTA Program. We will accept 10 qualified applicants into the professional phase of the hybrid PTA Program in January. To qualify, applicants must complete a minimum of 17 credit hours of general education courses to include BIOL 2214, ENGL 1013, HIM 1123 or CISQ 1103, MATH 2103 OR MATH 1003, PSYC 2003, and AHSC 1001 by the end of the Fall semester the year they are applying to be eligible for consideration for acceptance into the professional phase of the program. This application must be completed, and consent forms must be turned in to the Health Professions PTA Program by **November 1st**. We will begin the process of ranking applicants based on courses they have taken, but the final rank will not occur until all course grades are obtained at the end of the Fall semester.

Informed Consent Forms: These forms are required for application to the program. The forms are to ensure all applicants applying to the program have what we call "informed consent". Informed consent means we have notified the applicant of important information that could affect their ability to be accepted into the program, complete the program, and become licensed. Please read the informed consent forms carefully to ensure you understand the requirements an applicant must meet to be considered eligible for admission into the professional phase of the program, the ranking system used to select applicants, clinical education requirements, and licensure information. Submit the signed informed consent forms via the online portal. You must sign the "informed consent" forms to prove you have been provided this information before application and acceptance into the PTA Program. Applicants should also have a witness sign the forms before turning them in. A witness is anyone who sees you sign the forms, such as a friend, family member, etc.. Submit the signed informed consent forms by **November 1st**.

Application for the William Nelson PTA Program Scholarship will now be completed through the NWACC Foundation scholarship page. Application processes have been streamlined and when you complete the application at the following link, <a href="https://nwacc.awardspring.com">https://nwacc.awardspring.com</a>, the system automatically submits your information for all applicable scholarships. The PTA program is a two-year associate degree program consisting of 9 general education courses and 26 PTA lecture and lab courses. PHTA 2105 Clinical Kinesiology is not considered a "professional course" and may be taken without application to the program if desired.

General Education Courses: The following courses must be taken before admission to the program.

- BIOL 2214 Anatomy & Physiology I
- ENGL 1013 Composition I
- PSYC 2003 General Psychology
- HIM 1123 Electronic Health Records OR CISQ 1103 Introduction to Computer
- HIM 1001 Intro to Medical Terminology
- MATH 1203 College Algebra OR MATH 1003 Survey of Professional Math (not considered in the GPA requirement)

If not previously taken, the remaining General Education Courses listed below must be combined with the "Professional Courses" during the first spring semester of the program. These courses are required to complete the degree plan. You may choose to take these courses prior to this semester if desired.

- BIOL 2224 Anatomy and Physiology II
- ENGL 1023 Composition II
- PHTA 2105 Clinical Kinesiology in Physical Therapy

There will be no course substitutions for Clinical Kinesiology

Requirements and Selection: Provides a general overview of the requirements for application to the hybrid PTA Program, and information *regarding the ranking formula used to select the top 10 applicants* who will be offered a position into the professional phase of the hybrid PTA Program. Applicants are required to perform an interview process with the PTA Selection Committee. Applicants will be contacted in late fall, so times and dates may be established NOTE:

Students must attend mandatory lab courses 2 times in the spring semester and 5 times a semester starting the first Summer semester and weekly class meetings via TEAMS at times TBD.

#### Criminal background checks for clinicals:

Applicants must also perform 9 hours of observation with 3 hours minimum at 3 different physical therapy sites as part of the application. We recommend applicants schedule the observations *early* to ensure they are *completed before the due date of the PTA Program application.* 

Applicants must also undergo a physical by a medical doctor of their choice. After completing the physical, the physician must sign the "Physician Certification of Essential Functions and Physical Abilities" form.

**Checklist**: provides information regarding what students must submit to the NWACC registrar. If an applicant is using courses taken at another institution as part of the PTA Program pre-requisite courses, they must provide the NWACC Registrar with an official transcript for those courses. Students must submit proof of immunizations to include measles and rubella if born January 1, 1957 or after, to the NWACC Registrar AND the Health Professions Division PTA Program.

Please use the checklist to assist you in completing all the required activities and forms for your application to the Physical Therapist Assistant Program at NorthWest Arkansas Community College. Organize the forms in the order they are listed on the checklist and submit online. Applicants must *complete* each step of the admission process. **Timeline:** provides a process timeline to help you understand when items are due and when to expect further communication.

Final selection for applicants admitted will be made by the Physical Therapist Assistant Program Selection Committee. The Selection Committee has the right to make a final decision for student admission.

## PHYSICAL THERAPIST ASSISTANT REQUIREMENTS AND SELECTION

Students must have achieved a 3.00 GPA in 14 of the 17 hours of general education courses which are required for application to the program. Students must also earn a "C" or higher in all other general education and PTA Program Professional courses to remain in the PTA Program and graduate with an AAS in PTA. While MATH 1203 or MATH 1003 must be completed for application to the program it will not be considered in the GPA requirement.

Enrollment is limited by class size: The Physical Therapist Assistant Hybrid Program may only admit 10 students per year in January. The top ranked 10 students who meet all the criteria will receive an invitation for admission into the Physical Therapist Assistant Hybrid Program. If any of the students offered admission decline the invitation, applicants on the alternate list will be notified and offered a position beginning with the first alternate based on total points.

#### **DEGREE AUDIT INFORMATION:**

A degree audit identifies the progress a student has made toward an NWACC degree plan and determines the specific credits that NWACC will allow to a student from another institution. There is no charge for a degree audit.

Who should request an audit? Students will want to request a degree audit only if they plan to receive a degree from NWACC.

#### When should a student request an audit?

- If a student has completed coursework successfully at another institution
- Before a degree audit can be completed; **official** transcripts from **all** institutions attended **must** be on file in the Enrollment Support office.

#### Physician Certification of Essential Functions and Physical

**Essential Functions and Physical Demands:** Students who wish to pursue a career in Physical Therapy Assistant must meet the following essential minimal physical, mental and job standards in order to successfully complete the educational activities in the Physical Therapy Assistant program.

Admission to the NWACC Physical Therapy Assistant program is conditional on the candidate's ability to satisfy these professional standards, with or without reasonable accommodation. Reasonable accommodations will be made on an individual basis.

Students who have special needs are encouraged to identify themselves to the Program Director and the Disability Resource Center for reasonable accommodations. Reasonable accommodations will be based on current documentation provided to the Disability Resource Center.

The following professional standards and essential skills are functions that must be met with or without reasonable accommodations: The American Physical Therapist Association lists their Professional Standards as "Essential Qualifications" as listed below:

#### **Motor Skills**

Candidates shall have sufficient motor function so that they are able to execute movements required to provide general care and treatment to patients in all health care settings. [For example: For the safety and protection of the patients, the candidate must be able to perform basic life support, including CPR, and function in an emergency situation. The candidate must have the ability, within reasonable limits, to safely assist a patient in moving, for example, from a chair to a bed, examination table, or from a wheelchair to another location.

#### Sensory/Observation

A candidate must be able to acquire the information presented through demonstrations and experiences in the basic and profession's sciences. He or she must be able to observe a patient accurately, at a distance and close at hand, and observe and appreciate non-verbal communications when performing an assessment and intervention or administering of treatment. The candidate must be capable of perceiving the signs of disease and infection as manifested through physical examination. Such information is derived from images of the body surfaces, palpable changes in various organs and tissues, and auditory information (patient voice, heart tones, bowel and lung sounds).

#### Communication

The candidate must communicate effectively and sensitively with other students, faculty, staff, patients, family, and other professionals. He or she must express his or her ideas and feelings clearly and demonstrate a willingness and ability to give and receive feedback. A candidate must be able to: convey or exchange information at a level allowing development of a health history; identify problems presented; explain alternative solutions; and give directions during treatment and post-treatment. The candidate must be able to communicate effectively in oral and written forms in English. The candidate must be able to process and communicate information on the patient's status with accuracy in a timely manner to members of the health care team. The appropriate communication may also rely on the candidate's ability to make a correct judgment in seeking supervision and consultation in a timely manner.

#### Cognitive

A candidate must be able to measure, calculate, reason, analyze, integrate and synthesize in the context of undergraduate professional study. The candidate must be able to quickly read and comprehend extensive written material. He or she must also be able to evaluate and apply information and engage in critical thinking in the classroom and clinical setting.

#### Behavioral/Emotional

A candidate must possess the emotional health required for the full utilization of his or her intellectual abilities, the exercise of good judgment, the prompt completion of all responsibilities attendant to the diagnosis and care of patients and families. In addition, s/he must be able to maintain mature, sensitive, and effective relationships with patients,

students, faculty, staff and other professionals under all circumstances including highly stressful situations. The candidate must have the emotional stability to function effectively under stress and to adapt to an environment that may change rapidly without warning and/or in unpredictable ways. The candidate must be able to experience empathy for the situations and circumstances of others and effectively communicate that empathy. The candidate must know that his or her values, attitudes, beliefs, emotions, and experiences affect his or her perceptions and relationships with others. The candidate must be able and willing to examine and change his or her behavior when it interferes with productive individual or team relationships. The candidate must possess skills and experience necessary for effective and harmonious relationships in diverse academic and working environments.

#### **Professional Conduct**

Candidates must possess the ability to reason morally and practice in an ethical manner. Candidates must be willing to learn and abide by professional standards of practice. S/he must possess attributes that include compassion, empathy, altruism, integrity, honesty, responsibility and tolerance. Candidates must be able to engage in patient care delivery in all settings and be able to deliver care to all patient populations including but not limited to children, adolescents, adults, developmentally disabled persons, medically compromised patients, and vulnerable adults.

#### **Physical Abilities**

Static strength (ability to exert maximum muscle force to lift, push, pull or carry objects) and flexibility (the ability to bend, stretch, twist or reach with your body, arms &/or legs). Physical abilities include: standing, walking, sitting, lifting, carrying, pushing, pulling, and/or hand function. Strength classification is Medium Work: Exerting 20 to 50 pounds of force occasionally, and/or 10 to 25 pounds of force frequently, and/or greater than negligible up to 10 pounds of force constantly to move objects.

#### NWACC PTA Program Application Observation Informed Consent

**Observation Requirements:** A minimum of nine (9) hours of observation of the practice of physical therapy is required. The total observation time is to be divided into a minimum of three hours at three different physical therapy facilities. The observation requirement may be met by observation, volunteer or paid working time. However, a minimum of three different locations and a minimum three-hour block of time at each is mandatory.

It is the student's responsibility to make arrangements with the physical therapy departments for this experience. We have no lists or preferences of clinics. DO NOT contact the department for recommendations or assistance with this observation. This should be done independently by the applicant. The applicant must schedule the observation time with the physical therapy department director of the clinical site prior to the actual observation. Additionally, the applicant will need to inform the department director at the facility of the purpose of the observation. Applicants should inquire about specific dress and parking requirements. If the department does not have a specific dress requirement, the applicant is to dress in nice slacks (no jeans), a dress shirt and comfortable, clean walking shoes (with closed heel and toes).

It is the student's responsibility to take the Clinic Observation Confirmation Form to the clinic and ensure the person they meet with and observe signs the confirmation form. It is the student's responsibility to provide the signed confirmation form with their PT Program Application.

#### PTA Program Curriculum Work Recommendation:

The hybrid PTA Program curriculum is very demanding with many hours of required coursework. It is recommended that students work no more than 20-25 hrs/week. Applicants accepted into the professional component of the PTA Program must take and pass all professional courses offered each semester with a "C" or higher to remain in the PTA Program. Students who do not meet the requirement of a "C" or higher in any course may be dismissed from the PTA Program

# NWACC PTA Program Application Student Health, Physician Certification, Physical Condition, and Disability Informed Consent Form

Students who are accepted into a Health Professions program must be able to perform course related physical activities. A copy of the essential functions and physical tasks required for the program is included in this packet the student is required to have a physical and submit certification from a physician that the student is able to perform the related essential functions and physical tasks required for this profession. Proof of physical and the student's ability to perform the essential functions and physical tasks of a physical therapist assistant is to be submitted with the application packet. A copy of the essential functions and physical demands is included for the student to take to the physician. In the event a student becomes pregnant, a written statement is required from a medical doctor stating that the physical exertion required during the course work and clinical work is not contraindicated. After the delivery, written notice is required from a medical doctor that releases the student to return to the normal course related activities of that particular program.

In the event of an extended (anything beyond four days) illness, injury, or surgery, two letters must be submitted by a medical physician. The first letter is due upon the onset and should state the problem, restrictions, and prognosis. The second letter should state fitness to return to normal course related activities and should be submitted prior to returning to the program.

The faculty and/or the advisory committee of individual programs reserve the right to make the final decision regarding a student's return to the program after a medical leave.

# Students who are admitted to the Program are required to submit proof of health insurance during the first spring session.
